David Anderson, President and CEO of NW Natural



David Anderson is NW Natural's President and Chief Executive Officer. He is also a member of the Board of Directors. Mr. Anderson previously served as NW Natural's President and Chief Operating Officer, Executive Vice President of Operations and Regulation, and as Senior Vice President and Chief Financial Officer. Before joining NW Natural, Mr. Anderson was Senior Vice President and Chief Financial Officer at TXU Gas. He previously held executive positions within TXU Corporation (formerly Texas Utilities) including Senior Vice President and Chief Accounting Officer, and Vice President of Investor Relations and Shareholder Services. Mr. Anderson is also a director on the following boards:

Barbara Briggs, Woman of Many Hats

Barbara is currently semi-retired and living on Silverlake in Cowlitz County, Washington. She spent the last 25 years as a business consultant working primarily with Non-profits and local government. In addition to providing Board Development, Strategic Planning and Facilitation services through her consulting business, at various times she worked as a real estate broker and served a four year term as a Hood River County Commissioner. She later served as the accounting department head in Morrow County Oregon and then as the Executive Director of Columbia Gorge Center (now Opportunity Connections). Her work and volunteer experience have generally centered around workforce, economic development and social services.

Jeanne Carver, Owner of Imperial Stock Ranch



Shaniko Wool Company is Jeanne's latest effort in support of wool and its timeless importance and role in the history of humankind.

Jeanne and husband Dan Carver, own and operate the historic Imperial Stock Ranch (est. 1871) in north central Oregon, which has produced sheep, cattle, grains and hay through its entire 148 years. In the late 1990's, with a collapsing wool market and a diminished U.S. textile infrastructure, they moved from commodity wool sales in a new direction. Similar to the farm-to-fork "slow food" movement that reconnects us to our food, Jeanne pieced together a fiber supply chain as close to home as possible.

Combining their ranch's heritage and mindful stewardship of land and animals in her marketing messages, she connected a growing customer base for textile products to the origin of those products. In an era of outsourcing and disconnect, she brought product traceability and accountability. Jeanne scaled her Imperial Stock Ranch effort while maintaining its intimate connection to land and animals, and became known across multiple segments of the U.S. textile industry.

In 2014, Jeanne and the Imperial Stock Ranch, became the face of Ralph Lauren's Made in America Olympic uniform program, and she was again their voice for American wool during the 2018 Winter Olympics. In 2017, Imperial Stock Ranch became the first ranch in the world certified under a *new* global program called the **Responsible Wool Standard**. Developed by Textile Exchange, it addresses the welfare of sheep and the land they graze on. With the launch of Shaniko Wool Company, Jeanne is supporting regional ranchers and scaling the supply of RWS certified wool in the U.S., meeting the needs and aligning values with many of today's apparel brands.

Jeanne serves on numerous boards related to agriculture. She received an **Orchid Award** given by the Portland Business Journal for Women of Influence in 2014, and the **Agriculture Connection Award** for Oregon Agriculture in 2014. She was also named one of **9 Female Farmers Changing the Fashion Industry** (2016) by the Pratt Institute of New York.

Dallas Fridley, Regional Economist, Oregon Employment Department

Dallas Fridley has been employed by the Oregon Employment Department since December of 1991, including Regional Economist – based in Hood River – since October of 1995 and as an Employment Economist – in Salem. Prior work experience includes one year as a Community Development Planner for the Umpqua Regional Council of Governments in Douglas County and three years as an Economic Development Planer for the Central Oregon Intergovernmental Council in Deschutes County. Dallas attended and graduated from Willamette University in Salem Oregon with a BS in Economics. He is a native of Central Oregon and attended Crook County schools. Dallas currently lives in Hood River and is married with three children.

Mike Graham, Founder of Real Carbon



Mike Graham originally from St. Andrews in Scotland, moved to the US in 1987. Mike is a Chemist with an Honors degree in Chemistry from the University of London. He is currently serving as President of Real Carbon Inc., and on the board of directors of the Gorge Technology Alliance, and Technology Association of Oregon. Mike still windsurfs, skis, and plays golf in his free time.

Real Carbon Inc. started in a garage in California, with a dream of lightweight, super strong and very fast Windsurfing boards. Karbon Kreation, as the company was originally called, built the world's first pre-preg carbon fiber board in 1988. Today, twenty-nine years later, the company, now called Real Carbon Inc., is based in Hood River, Oregon.

Amanda Hoey, Executive Director Mid-Columbia Economic Development District



Amanda Hoey is the Executive Director for Mid-Columbia Economic Development District (MCEDD), a bi-state regional economic development entity supporting the Columbia Gorge region of Oregon and Washington.
